The "Stringtown Shootout" occurred on August 5, 1932, in Stringtown, OK, when Clyde Barrow, of Bonnie and Clyde infamy, along with Raymond Hamilton and Ross Dyer shot it out with Atoka County lawmen. Having left Bonnie Parker with her mother in Dallas, TX, the three outlaws were travelling north in a stolen car looking for adventure when they were drawn to the live music and spectacle of a dance being held in the rural town.

Trouble soon broke out when the three strangers, in expensive suits and drinking Bootleg booze, began mingling with the locals. Sherriff Charlie Maxwell and Deputy Eugene Moore approached the men in their car and told them they were under arrest. Barrow and Hamilton responded with gunfire, catching the lawmen off-guard. Sherriff Maxwell was severely wounded and Deputy Moore was killed. Barrow and Hamilton fled in the stolen car leaving Dyer behind, who managed to slip away after mingling with the crowd.

Emailing Daily Reports

Understand that we will only request new or updated agreements, licenses, and disclaimers that are required for the legal use of our loan accounting products, and for which, we must retain a signed copy on file.
