# What's New, FSS?



The Second Battle of Cabin Creek, occurred on September 18, 1864 near the town of Big Cabin, in NE Oklahoma. A Confederate force of 2,000, led by General Stand Watie, and composed mainly of his Indian Brigade, attacked a Union supply train en route from Kansas to Fort Gibson. The convoy of 130 wagons with supplies worth approximately \$1.5 million was captured after a heavy engagement.

Stand Watie was the Principal Chief of the Cherokee Nation during the Civil war, and was the only Native American to attain the rank of General in the CSA. He commanded the Indian Calvary of the Army of the Trans-Mississippi, composed primarily of Cherokee, Muskogee, and Seminole Indians.

## Deposit Function

If you are still using regular Cash Transfers to post your deposits, consider using the "Deposit" button. The Deposit button is found in the Cash Transfer screen, and offers increased functionality for posting your deposits to the checkbook.

The Deposit option is fast, and allows you to specify how much in Cash, Checks, and Debit Card payments you will be depositing to your checkbook.

Using a dropdown menu, you can even specify from which drawer each of these types of funds will be deposited. The Deposit function even comes with a Reverse feature, which can only be used while the posting period is still opened. It will not allow deposit reversals from closed days.

There is also a useful report that lists the details of each deposit posted. Look for the Deposit button at the top of the Cash Transfer screen when posting your next deposit. If you have questions, give us a call, we're happy to help!

## Scheduled Events

The Event Scheduler allows you to schedule these and many more reports and functions in whatever frequency best suits your business. And like other LoanPro options, it's easy to use.

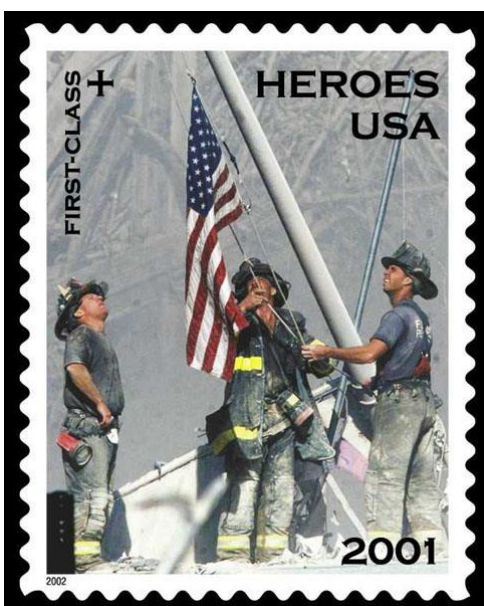

## Credit Bureau Rejection Reports

Did you know your Credit Bureau will provide you with a Rejection Report that lists borrowers with account information that was rejected during the reporting process? FSS provides a similar report, but our report lists your borrowers' information that was not sent to the Credit Bureau. This happens because of issues generally associated with data entry errors, such as address or SSN information entered in LoanPro using an incorrect format.

However, the Rejection Report from your Credit Bureau lists any borrowers that your Credit Bureau was unable to process. Basically, the FSS report is proof that your data was sent to the Credit Bureau, and the Credit Bureau report is proof that they processed it.

To begin receiving the Credit Bureau rejection report, contact your chosen Credit Bureau, and tell them you want to get signed up. It's a valuable tool for ensuring you are getting the most out of your subscription, and safeguarding your customers' valuable credit information.



On the morning of September 11, 2001, four passenger airliners were hijacked by Islamic extremists associated with the al-Qaeda terror group in a vicious and unprecedented terrorist attack. One airliner was flown into each of the World Trade Center towers, and a third was flown into the Pentagon Building. The fourth airliner crashed into a field near Shanksville PA, when passengers rushed the cabin and attempted to regain control of the airplane. The attacks killed a total of 2,996 people.

The event served to unify the country in a way not seen since Pearl Harbor, and mobilized the nation to bring those responsible to justice.

After nearly a decade evading US forces, al-Qaeda leader Osama bin Laden was found killed by the US Navy's SEAL Team Six in Pakistan on May 2, 2011.
